12-98 **BOARD FORUM**

Mrs. Davis asked to pull Item II (7) Energy Performance Contract, from the agenda for a future meeting. Mr. Allen asked to pull Item II (4) Acceptance of Audit, from consent.

12-99 **DISTRICT UPDATE**

Mrs. Davis handed out a letter to parents that Mrs. McGahey drafted announcing a public information night on November 27, 2012 regarding school mergers for the board to review. Remsen Central School District has been discussing the process of school mergers. Mrs. McGahey commented that this is purely an information night and we would like to make community members aware of the process. Mrs. Davis noted that the board meeting for November 14, 2012 will be cancelled and rescheduled for November 27, 2012 so we are able to have the meeting and public information night at the same time. We will be having the same consultant that presented in Remsen along with District Superintendent Howard Mettelman.

Mrs. Davis also noted that she is working with the School Boards Association for the possibility of going to an electronic system for our board packets in the future.

Mrs. Davis noted that the Early Retirement Notice is on the agenda. We are also recommending the elimination of the old incentive policy which was never deleted. The Early Retirement Notice policy is invaluable in the budget process. Mrs. Davis and Mr. D'Ambro anticipate another tough budget year. The early notice makes staffing projections more realistic.

The Graduation Ranking Policy (#7014) needs revision. As reported by Mrs. Nowicki, we are unable to accommodate the weighted average in each marking period. She reported that NCAA, some scholarships, and most colleges require an unweighted average. Quarterly weighting does not mesh with our Data Warehousing and School Tools software. She recommends eliminating Item II, first sentence "All averages will be completed quarterly." Another area of concern is New Visions. Weighting will be reviewed at a later date. Mr. Allen expressed interest in knowing how the rigors of the New Visions program compare to other weighted courses. It was agreed that, at this time, parents would be notified of their child's weighted average at end of the junior year and second semester of the senior year.

Mrs. Boris noted that acceptance of the Internal Claims Audit report should be added to the agenda. We will mark it as Item II (4a).
