The Board of Education of the Holland Patent Central School District hereby agrees to hire the law firm of Hancock & Estabrook to represent them in the defense of the tax certiorari proceedings brought against the Town of Marcy and authorize the law firm to appear and intervene on their behalf.
- 2. The Board of Education of the Holland Patent Central School District hereby agrees to pay and be responsible for 6% of the legal services of Hancock & Estabrook in the defense of the tax certiorari proceedings, to include necessary appraisals and other costs and expenses related to the defense of those proceedings. Said bill shall be itemized for legal services and disbursements on a monthly basis and will indicate the charges made to each municipality based upon the percentages set forth.
